- 2012 Partnered with Dai Nippon Printing Co., Ltd. to strengthen business capabilities for expanding into new markets.
- 2013 The world's first open technology-based domestic airline passenger system goes live.
- 2021 The world's first public cloud-based full banking system goes live.
- 2022 Changed the corporate name from Nihon Unisys, Ltd. to BIPROGY Inc.



Breakdown of Sales by Market (FY2020)






