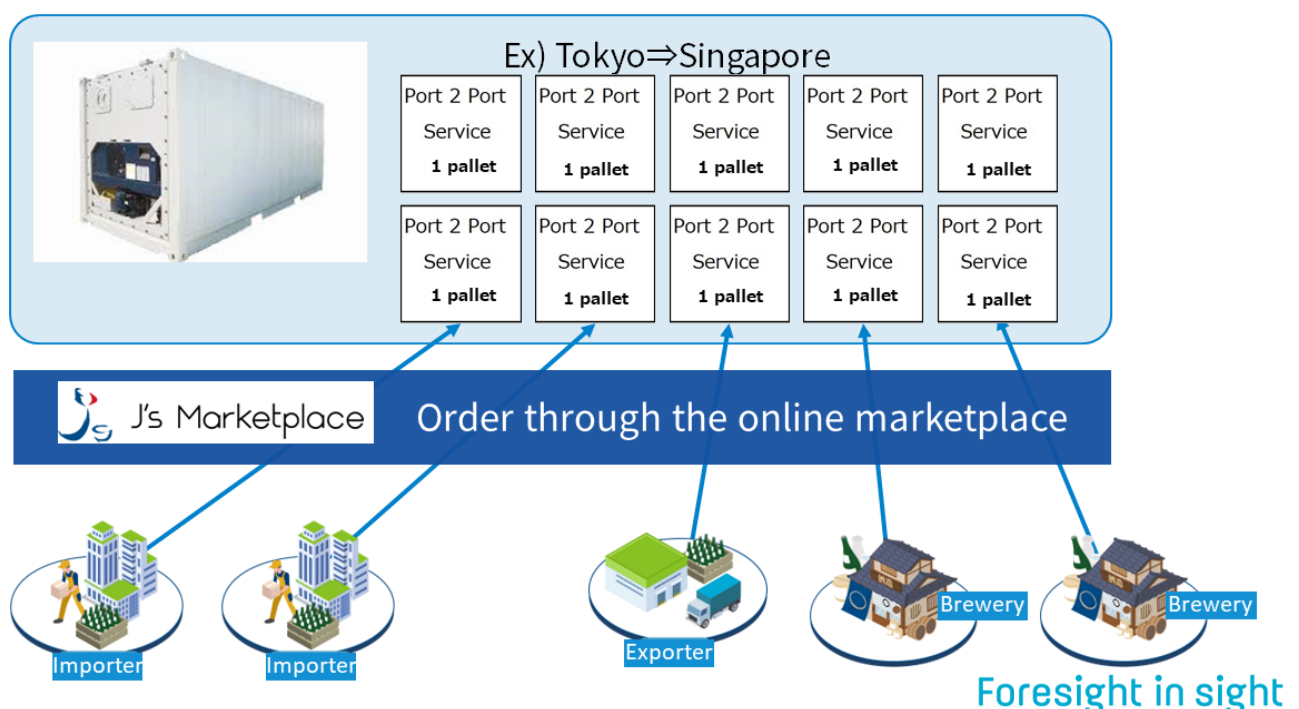
- Need to transport premium sake without quality deterioration

Conditions of sales

- Participation in J's Marketplace
 - Both importers and exporters are required to participate in J's Marketplace trial.
 - Importers are required to order products and transport through J's Marketplace.
- Transport
 - This transport service shall be contracted with Nissin Corporation("Nissin").
 - The cargo must be transported from the brewery to the warehouse in Japan specified by Nissin by the specified date.
 - Each company shall pick up the goods on pallets at each destination side.
 - The schedule is subject to change or to be delayed due to vessel bookings or various circumstances.
 - The cargo will be stored at room temperature in the CFS warehouse in Ho Chi Minh.
- Price details
 - The fees are special prices for first trial only.
 - The number of pallets purchased is limited to 3 pallets per order per customer.
 - The fees include ocean freight costs, export customs clearance fees, insurance costs, import customs clearance fees and local warehouse storage fees.
 - The maximum number of cases loaded per pallet may be restricted.
*Maximum assumption: approximately 36 cases (720 ml x 12 bottles).
 - Japanese consumption tax will be charged separately for costs in Japan.
